This is the final response to your December 17, 2017, Freedom of Information Act (FOIA) request, a copy of which is attached for your convenience. We received your request on December 18, 2017 and assigned it FOIA case number 18-F-0324. We ask that you use this number when referring to your request.

The Executive Services Directorate (ESD), a component of the Office of the Secretary of Defense (OSD), conducted a search of their records systems based on the information provided in your request. After thorough searches of the electronic records and files of ESD, no documents of the kind you described could be identified. We believe that this search method was appropriate and could reasonably be expected to produce the requested records if they existed. Further, we have determined that the information you are seeking may fall under the cognizance of the Defense Intelligence Agency (DIA). As DIA operates its own FOIA/PA office, we have forwarded your request to their office for direct response to you. 

Your appeal must be postmarked within 90 calendar days of the date of this response.
