Dear Mr. Greenewald:

This letter is in response to your Freedom of Information Act (FOIA) request, dated September 14, 2016, and received in our office on the same day. The tracking number is 2016-00994. In your letter, you asked for the following:

"I respectfully request a copy of records, electronic or otherwise, pertaining to the dispute over the discovery in 1990, of the fossilized remains of a Tyrannosaurus Rex, in the Cheyenne River Indian Reservation in western South Dakota near the city of Faith.

Soon after the fossils were found, a dispute arose over their legal owners. The Black Hills Institute had obtained permission from the owner of the land, Maurice Williams, to excavate and remove the skeleton, and had, according to Larson, paid Williams US\$5,000 for the remains. Williams later claimed that the money had not been for the sale of the fossil and that he had only allowed Larson to remove and clean the fossil for a later sale. Williams was a member of the Sioux tribe, and the tribe claimed the bones belonged to them. However, the property that the fossil had been found within was held in trust by the United States Department of the Interior.

I please ask that you include all reports, letters, memos, investigation files, interagency communications, court documents, photographs and videos that pertain to the above event.

After a thorough search of our files, we have determined that the Bureau of Land Management (BLM) has no records responsive to your request. The records you seek may reside with the Bureau of Indian Affairs.

You may appeal this no records response to the Department of the Interior's FOIA/Privacy Act Appeals Officer. If you choose to appeal, the FOIA/Privacy Act Appeals Officer must receive all documentation listed below no later than 90 workdays from the date of this letter. Appeals arriving or delivered after 5 p.m. Eastern Time, Monday through Friday, will be deemed received on the next workday.

Your appeal must be made in writing. You may submit your appeal and accompanying materials to the FOIA/Privacy Act Appeals Officer by mail, courier service, fax, or email. All communications concerning your appeal should be clearly marked with the words "FREEDOM OF INFORMATION APPEAL." Send your appeal and accompanying materials to:
