1.	P.L. 93-531, as amended by P.L. 96-305, authorized the acquisition of 400,000 acres of land to be taken into trust to be used for the benefit of those Navajo families residing on the Hopi Partitioned Land with such land to be administered by the ONHIR until relocation is complete. The land was purchased and developed. The ONHIR installed infrastructure, chapter facilities and developed the Rural Community and Range Units.  <u>New Lands Video</u> , in both English and Navajo, commissioned by the ONHIR for the purpose of describing the New Lands to relocatees who might be interested in relocating to the area. This video focuses primarily on the Range Units.  Disposition: Permanent. Transfer to National Archives and Records Administration at the close of the ONHIR.		
2.	<u>New Lands Brochure</u> An illustrated brochure describing the New Lands; the type of homes being constructed as well as proximity to health care facilities, school, and employment opportunities. There are no associated electronic mail or other word processing records.  Disposition: Permanent. Transfer to National Archives and Records Administration at the close of the ONHIR.
