On 10/14/92, HARVEY L. SILBERT, Attorney (represents victim FRANK SINATRA), LOEB & LOEB, 10100 Santa Monica Boulevard, Suite 2320, Los Angeles, California 90067, telephone number (310) 282-2230, reported that FRANK SINATRA has received a series of nine rambling, threatening letters. The letters were addressed to SINATRA's home address (20-588 Sinatra Dr., Rancho Mirage, CA) and showed a return address of Detroit, MI 48216.

In the first letter, dated 9/16/92, the subject demands a private concert at the Fox Theater in "Mo-Town" (Detroit) at 8:00 p.m. on 12/12/92. In a letter dated 9/12/92, tells SINATRA to "scratch" his 11/8/92 concert at the "Palace" in Auburn Hills. SILBERT reported that SINATRA, along with SHIRLEY MACLAINE, will perform at "The Palace" in Auburn Hills, MI on 11/8/92. In that same letter, states that "Your next and last concert is Dec. 12, 1992 Sat. at the Fox Theater 8:00 p.m." According to SILBERT, SINATRA is scheduled to appear at the Desert Inn, Las Vegas, NV, 12/8-12/92.

The letter, dated 9/30/92, is addressed to at SINATRA's residence. Makes reference to "understanding" Easter Sunday, April 1981; that this was first Easter Sunday that he had not taken his mother to church; she died 9/25/80; and that suit "would have been a mess if I had to drag you out to the green - 4 door sedan across the street in Catheral City." At the end of the letter, a Merry Christmas and Happy New Year. According to SILBERT, SINATRA are close friends and has stayed at the SINATRA's home; however, this is not public knowledge. did stay at the SINATRA residence in December 1991, during the holidays.

THOMPSON opened and read the letters and because of the threats had them hand delivered to SILBERT on 10/12/92. The last three letters, dated 9/29/92, 9/30/92 and 10/4/92, were also received by KERN and forwarded, unopened, by Federal Express, to SILBERT. SILBERT received these letters on 10/14/92 and opened and read them.

SILBERT has made SINATRA's manager, ELIOT WEISMAN, PREMIER SERVICES, INC., 1401 University Drive, Coral Springs, Florida 33071, telephone number (305) 755-1700, aware of the letters. SINATRA is in New York, New York, and, as of 10/14/92, not aware of the threat.




