This is the final response to your March 12, 2018 Freedom of Information Act (FOIA) request, a copy of which is enclosed for your convenience. We received your request on March 12, 2018 and assigned it case number 18-F-0644. We ask that you use this number when referring to your request.

The Defense Office of Prepublication and Security Review (DOPSR), a component of the Office of the Secretary of Defense, conducted a search of their records systems and located 16 pages, determined to be responsive to your request. Mr. Robin Patterson, an Initial Denial Authority for the Department of the Navy determined that portions of the responsive pages contain information about a party other than yourself. Because you only have access rights, under the Privacy Act, to information that is about you, your access rights to this information are limited to the FOIA. As such, the Department of the Navy determined that portions of the documents that are not about you are exempt from disclosure pursuant to the provisions of the Freedom of Information Act, Title 5 U.S.C. § 552, exemption (b)(6), as disclosure of the information would constitute a clearly unwarranted invasion of the personal privacy of the individuals involved.

In this instance, fees for processing your request were below the threshold for requiring payment. Please note that fees may be assessed on future requests.

1) All DD Form 1910's filed by Mr. Luis Elizondo to get videos declassified for public release. Specifically, Mr. Elizondo worked through OSD on the "Advanced Aviation Threat Identification Program" or AATIP. According to Mr. Elizondo himself in an interview he conducted, he specifically stated he filed DD Form 1910's to get at least three videos declassified to the public.

Please include these DD Form 1910's submitted by Mr. Elizondo to the Defense Office of Prepublication and Security Review (DOPSR).

2) I also ask that you include all correspondence relating to these DD Form 1910s, sent to/from Mr. Luis Elizondo and the DOPSR office.

3) I ask that you include all other DD Form 1910s, submitted, that pertain to any/all material connected to the "Advanced Aviation Threat Identification Program" or AATIP. Please include all requests by any individual.

I also ask that this request be expedited and all fees waived. For the same line of reasoning I

have expressed in related request, I will not submit the 27 page explanation in this letter.

However, if this is denied, I ask that you include my appeal rights as I will exercise them in this instance.



Per your guidance, please find the attached three .mpg files for your review. Please note, although the files are UNCLASSIFIED, they are being sent via SIPR in the spirit of extra precaution. No locational data is provided in any of the files and therefore there should be no classification issues.

STRATEGIC ISSUE: Unmanned aerial vehicles (balloons, commercial UAVs, private drones such as quadcopters, etc) continue to pose a potential threat to DoD facilities, equipment, and location. Army, Navy, and Air Force have all acknowledged the potential threat by UAS' to DoD equities but no single UNCLASSIFIED repository exists to share this information across all stakeholders.

PURPOSE: Our collective purpose is to eventually establish an UNCLASSIFIED database or "Community of Interest" of related signature data to be accessible by stakeholders such as DIA, the Navy, Defense Industry partners, and perhaps even State, Local & Tribal authorities to catalog and identify specific UAS threats to national security and/or DoD equities. By creating a virtual library to catalog and analyze each event, our hope will be to better understand the capabilities, and ultimately vulnerabilities of these systems.

Per your guidance, please find the attached three .mpg files for your review. Please note, although the files are UNCLASSIFIED, they are being sent via SIPR in the spirit of extra precaution. No locational data is provided in any of the files and therefore there should be no classification issues.

STRATEGIC ISSUE: Unmanned aerial vehicles (balloons, commercial UAVs, private drones such as quadcopters, etc) continue to pose a potential threat to DoD facilities, equipment, and location. Army, Navy, and Air Force have all acknowledged the potential threat by UAS' to DoD equities but no single UNCLASSIFIED repository exists to share this information across all stakeholders.

PURPOSE: Our collective purpose is to eventually establish an UNCLASSIFIED database or "Community of Interest" of related signature data to be accessible by stakeholders such as DIA, the Navy, Defense Industry partners, and perhaps even State, Local & Tribal authorities to catalog and identify specific UAS threats to national security and/or DoD equities. By creating a virtual library to catalog and analyze each event, our hope will be to better understand the capabilities, and ultimately vulnerabilities of these systems.
