


According to the Articles of Incorporation, each of the above individuals agreed to take one share of stock in the cerporation.

The Incorporation papers were notarised by VEIT E. KAUFMAN, Attorney and Counsellor at Law.

Records maintained in the New York County Clerk's Office, reflect that a Certificate of Incorporation for the JAY RICHARD KENNEDY Management Corporation was filed on September 7, 1940 by SIDNEY KRAMER and STANLEY LEVISON, Lawyers at 110 East 42nd Street, New York City.

Records of the New York County Clerk's Office, reflect that SIDNEY KRAMER, Attorney at Law, 110 East 42nd Street, New York City, filed a Certificate of Incorporation for the L. Realty Company and further that SIDNEY KRAMER, with an address listed as 70 West 40th Street, EILEEN COOPERMAN of the same address and STANLEY LEVISON, 285 Madison Evenue, were original directors and shareholders of the L. Realty Company.

New York County Clerk's Office records also reflect that the . Certificate of Incorporation for the Horizon Import and Export Company was filed by Attorney SIDMEY KRAMER on December 12, 1946. The office of this firm was at that time listed as in care of SIDMEY KRAMER, 70 West Woth Street, New York City. SIDMEY KRAMER was designated as one of the directors in this firm until the holding of the first meeting of the stockholders.

New York County Clerk's Office records also reflect that SIDNEY KRAMER and STANLEY LEVISON, Attorneys, 110 East 42nd Street, New York City, prepared the Certificate of Incorporation for the J. F. TOEWI! Company, Incorporated, which was filed on August 21, 1940. The firm was incorporated to engage in the general real estate and brokerage business. The office of





the corporation was listed as being in care of SIDNEY KRAMER at 110 East 42nd Street, New York City. Among the officers of the corporation listed as designated to serve until the first annual meeting of stockholders were SIDNEY KRAMER, STANLEY LEVISON and ROY BENNETT. It is to be noted that a Certificate of Dissolution for the J. F. ILO EVI Company, Incorporated was filed on November 13, 1945.

The records of the Essex County Hall of Records in Newark, New Jersey, reflect that SIDNEY KRAMER of 70 West 40th Street, New York City was designated as a holder of one share in the Washington Motor Sales Company, Incorporated, when that firm was incorporated on June 11, 1948.


