I refer to your email dated June 21, 2007, requesting the release of certain Department of State material under the Freedom of Information Act (Title 5 USC Section 552).

We initiated a search in the following record systems: the Central Foreign Policy Records (the principal record system of the Department of State) and the Bureau of Oceans and International Environmental Scientific Affairs. The search in the Central Foreign Policy Records has been completed, resulting in the retrieval of 13 documents that appear responsive to your request. The search in the other file is continuing and we will let you know when it is concluded.

THE APPARENT 1978 IMPACT AREA IS ABOUT FIVE MILES SOUTH OF BOTH, FORMING A TRIANGULAR PATTERN.) (THERE ARE NO EVIDENCES OF SHIELDING OTHER THAN THE MAGNETIC SPATTERING.)
